### **ELIGIBILITY**

The **Kristine M. Lawrence Scholarship** recognizes students who:

- Are enrolled in the EMT/Pre-paramedic Professional Certificate or a Paramedic degree at Great Falls College
- Have a minimum cumulative GPA of 2.50 on a 4.0 scale
- Are a resident of Cascade County, MT (Preference shall be given to a resident of Simms, MT or Fort Shaw, MT)

### **SCHOLARSHIP AWARD**

The **Kristine M. Lawrence Scholarship** will award one student scholarship annually, in the amount of \$1000. The awards will be disbursed in two equal segments; \$500 each term for Fall 2018 and Spring 2019 to the student account for payment toward tuition, fees, books, and supplies. Scholarship recipients must maintain satisfactory academic progress.

### **APPLICATION REQUIREMENTS:**

1. **Scholarship Application:** Complete the application form in its entirety.
2. **Personal Statement:** One concise statement in paragraph format briefly but specifically explaining why you feel you are deserving of this scholarship. Please limit your response to one typed page.
3. **Current Unofficial Transcripts:** Provide your most current high school or college transcript. **\*NOTE:** if you are a continuing GFCMSU student with an established GFCMSU grade point average, you are not required to provide a copy of your transcript.
